

1924–2009: Celebrating 85 Years of Service in Richmond

Formally Open Children's Memorial Clinic Tomorrow

Public Invited to Inspect Building at Eleventh and Clay – Begins Service Friday.

The Children's Memorial clinic of Richmond will be formally opened tomorrow at 11 o'clock and all are invited to inspect the building at 1001 East Clay, which on Friday will begin its service for the children...

In October of 1926, through a partnership with the Junior League, art and woodworking classes were offered to the young patients: prototypical **play therapy** – radical and untested at the time, but **now a staple of best-practice children's mental health therapy**.

In 1934, the 10th Anniversary Gala Dinner celebration was held at the Jefferson Hotel. **In attendance were more than 600 friends and supporters.**

In the early 1970s, the clinic moved into this location at 2319 East Broad Street.

In the early 1980s, the Prevention Department (now known as **Child Development Services**) was added to train and equip child care providers, parents and the community to better care for young children.

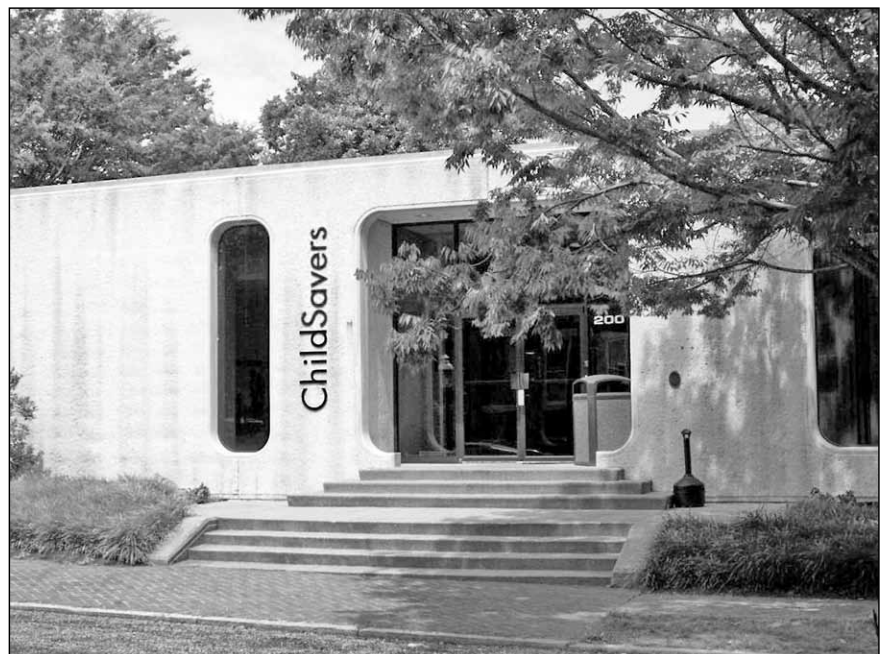


In the late 1980s we became **Memorial Child Guidance Clinic**.

In the fall of 2003, 200 N. 22nd Street (WRVA) came on the market. The building was purchased, and the administration staff moved to that site in early 2004, followed later by the program staffs.

In November 2004, the ChildSAVE program launched. Today, this program is known as **Trauma Response**.

In March, 2007 renovations began at 200 N. 22nd Street.

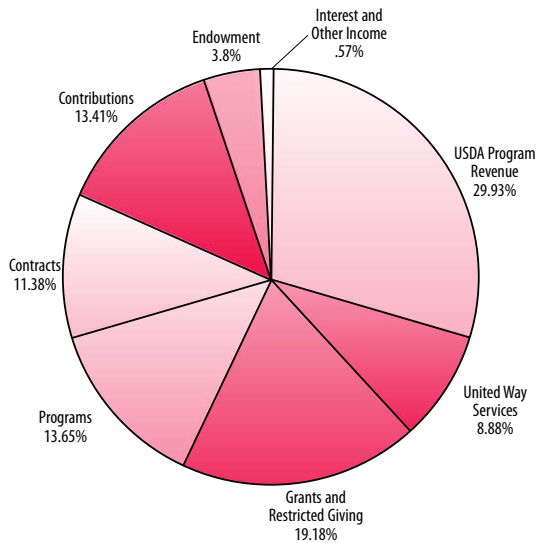

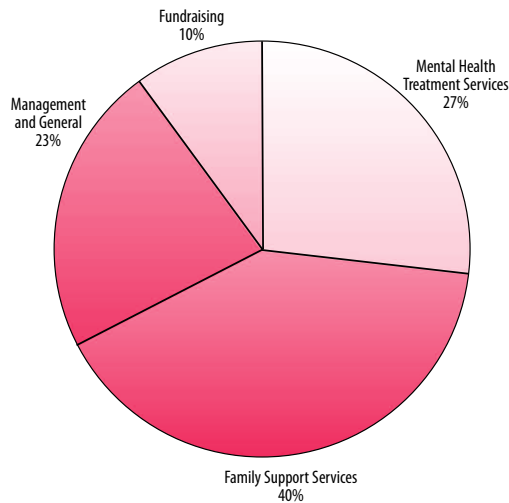

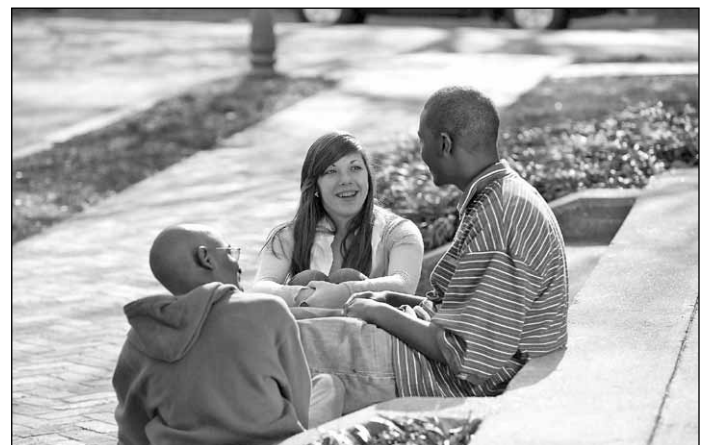
